### **European Partnerships – what and why**

European Partnerships are strategic instruments which enable long-term collaborations between the Union and public and/or private partners to tackle common challenges through the co-design and implementation of joint R&I programmes





Foster directionality of funding in line with EU policy priorities



### CREATING CRITICAL MASS

- Avoid fragmentation and duplication of R&I efforts
- Achieve greater scale and impact



### FOSTERING ECOSYSTEMS

- Integrated value chains and ecosysems
- Integrative activities outside of funding





### New approach under Horizon Europe

New generation of objective-driven and more ambitious partnerships in support of agreed EU policy objectives

**Key Features** 

- Increased ambitions
- Simplified architecture and toolbox
- Common set of criteria for the entire life-cycle (<u>Horizon</u> <u>Europe regulation</u> Article 10 and Annex III)

#### **CO-PROGRAMMED**

Based on Memoranda of Understanding/contractual arrangements; implemented independently by the partners and by Horizon Europe

#### **CO-FUNDED**

Based on a joint programme agreed and implemented by partners; commitment of partners for financial contributions and additional activities

#### **INSTITUTIONALISED**

Based on long-term dimension and need for high integration; partnerships based on Art 185/187 of TFEU and the EIT legal acts for 2021-2027

### **Strategic Coordinating Process**

- New governance framework for European Partnerships
- Supports evidence-based policymaking for partnerships and a strategic vision of the landscape
- Allows a consolidated view on the progress made by European
- To implement the strategic coordinating process, the Commission has set up:
  - The **Partnership Knowledge Hub (PKH)** a formal structure for collaboration between the Commission and the authorities responsible for the national coordination and participation in EU R&I partnerships from Member States and Associated Countries
  - The <u>Biennial Monitoring Report</u> (BMR) to create more harmonised monitoring and reporting framework for European Partnerships
  - The Partnership Stakeholder Forum, an annual event providing a venue for networking, broadening engagement, sharing of experiences and discussing policy and practical dimensions related to partnerships





### Avenues for synergies and collaboration

- Synergies between partnerships and other relevant instruments are essential to foster holistic and integrated approaches
- No top-down/one-size-fits-all solutions
- Some examples:
  - Clean Planet Inter-Partnership Assembly: harmonise and align activities of different partnerships
  - Joint calls between different partnerships and/or Missions
  - Collaborations with regional actors
  - Standing Committee on Agricultural Research

\*IHI two-stage calls: companies identified in the call topic are not eligible to receive IHI funding



#### IHI involves multiple healthcare stakeholders

Analysing the composition of the IHI consortia, all IHI projects (20 projects = 100%) involve more than two types of healthcare stakeholders as project participations.

This exceeds the targets set for 2023 (55%) and 2025 (60%)







#### **Example of project CLAIMS - 15 multi-stakeholder participations**




CLAIMS addresses Multiple sclerosis (MS), an autoimmune disease in which the immune system attacks the central nervous system. It currently affects around 3 million people worldwide. There is no cure, although there are treatments that can slow the progress of the disease. The aim of the CLAIMS project is to develop a diagnostic platform that would offer clinicians a holistic overview of the MS patient. The platform would predict how the patient's MS would likely progress with different treatments. The project brings together health care professional organisations/providers, SMEs, Large companies, NGOs and leading academics. Ultimately, the project hopes to validate the platform and submit it to medicines regulators for approval.





### IHI brings together several industrial sectors



Analysing the composition of the IHI consortia, almost all of them (19 out of 20 projects = 95%) bring together private members and/or contributing partners (or their affiliated or constituent entities) from two or more technology sectors.


This exceeds the targets set for 2023 (60%) and 2025 (65%).



### Example of project IMAGIO 16 academic and 15 industrial stakeholders active in 3 sectors



The IMAGIO project focuses on an approach called interventional oncology (IO) which targets cancer cells more precisely, thereby sparing healthy cells from the toxic effects of many treatments. In IO, miniaturized instruments (including biopsy needles, electrodes or catheters) are inserted into the patient's body via minimally invasive access routes. IO can be used to deliver diverse types of cancer treatments, including surgery, radiotherapy, chemotherapy and immunotherapy. The project brings together representatives of the medical technology, pharmaceutical and biopharmaceutical sectors as well as leading academic sectors. Together, they will explore and demonstrate how next generation IO imaging techniques can be applied to cancer research and treatment, from laboratory studies to clinical trials.





### **ERA4Health RRI Guidelines**



Responsible Research and Innovation (RRI) - ERA4HEALTH



#### WHAT IS ERA4HEALTH'S APPROACH TO RRI?

ERA4Health's approach to RRI is focused on improving the quality of research and innovation by keeping the broader context of your work visible. It encourages you to embed methodologies and processes to consider four important dimensions related to research and innovation:



Anticipation. What might the future desirable and undesirable effects of your work be? Who will benefit from it, and who might not? Can decisions be made now to encourage the good, while minimising the bad? This isn't about exhaustive prediction but about building a sense of preparedness for the future.



**Inclusion.** Whose voices and knowledge are shaping your research project? In health research, much evidence shows that patient organisations, health users and health professionals (amongst others) can improve the quality of innovation. Inclusion is about creating opportunities for two-way exchange of information, codesign or knowledge co-production to draw important outside voices into the research process.



Reflection. Are there opportunities for you and your team to pause and 'take stock' about what you're doing? Would everyone agree with your goals and the decisions you've taken so far? Reflection is about making sure there is space and time to collectively ask hard questions about a project's foundations.



**Responsiveness.** What are the key decision points in your project? Are there opportunities to change course, if you need to? The final dimension is a reminder that the work you do under the label of RRI needs to shape the design, governance or use of your research or innovation.

### **Antimicrobial resistance (AMR)?**

The ability of microorganisms to withstand substances that are used to kill or control them.

AMR is a global challenge that is threatening the life and health of people and animals, and also economic growth, food safety and sustainable development.



### One Health?

A unifying approach balancing the health of people, animals, and ecosystems, and recognising that they are interlinked and interdependent.



### In brief

- Co-fund partnership invited in the Horizon Europe work programme 2023/2024
- Continues the legacy of JPIAMR which has been active since 2011
- 10-year programme, starting in the spring 2025
- Annual calls for R&I projects, plus calls for research networks, mobility, and capacity strengthening

The vision of the EUP OHAMR is to reduce the burden of AMR.

This translates to improving the response to the threat of AMR by reducing the spread of AMR in humans, animals and the environment through an integrated OH approach, and by increasing the number of effective treatment options available



# Resources and experiences to share with other partnerships

- EUP OHAMR WP5 (lead: ZonMw, NL) will develop a FAIR-enabling research data management procedure for the projects funded by the partnership. A pilot study will demonstrate how FAIR research results can be analysed and further exploited with AI-methods beyond the partnership.
- EUP OHAMR WP2 (lead: DLR, DE) is dedicated to relations and synergies with AMR specific and AMR sensitive stakeholders: HE partnerships, JA:s, PPP:s, global collaborations etc.
- Alignment with national programming: AMR strategies and action plans are available on the EU and global levels, and many countries have national action plans (following UN guidance).






